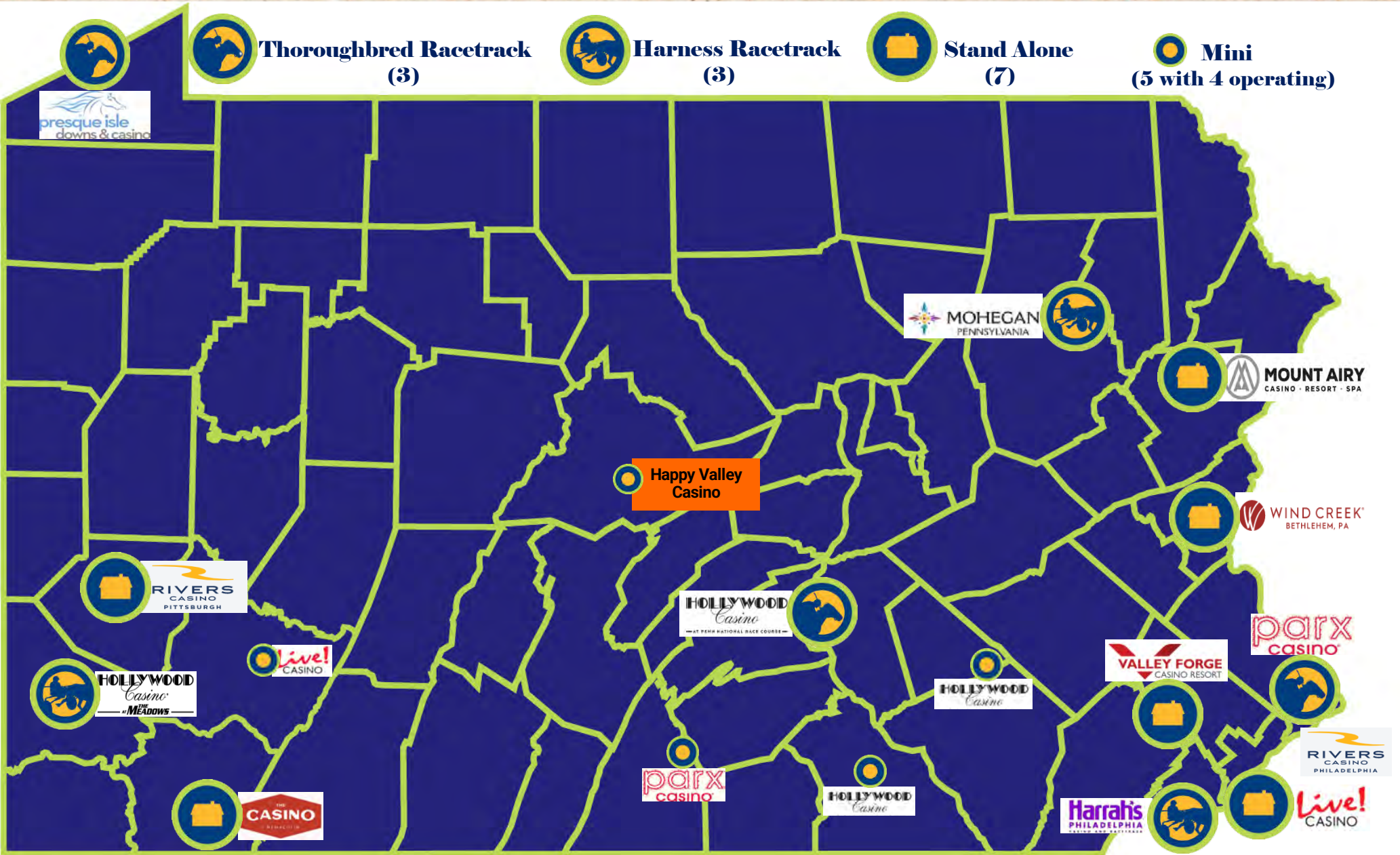

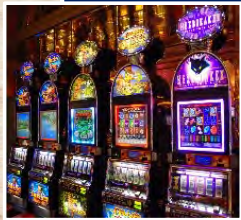

## Self-Exclusion Data

While gambling may be a form of entertainment for most people, it is a harmful addiction for others. The Pennsylvania Gaming Control Board offers self-exclusion programs to help individuals affected by problem gambling distance themselves from the temptation of gambling. Self-exclusion allows these individuals to voluntarily ban themselves from casinos, internet-based gambling, video gaming terminals and fantasy sports wagering. Below is an interactive report that will allow you to view various data points related to Self-Excluded patrons for different gaming types.

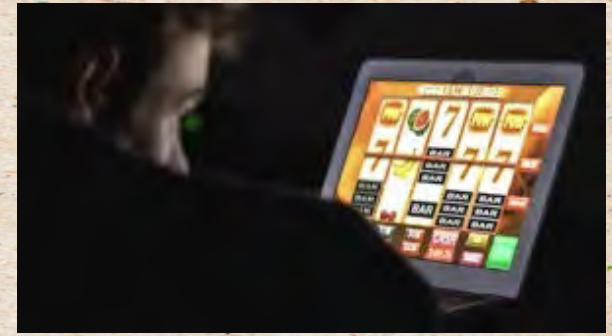

# Advertising Standards Current

## Advertisements must not:

Contain false or misleading information

Contain indecent and/or offensive graphics

Contain content that contradicts the game rules or terms and conditions.

Specifically target players who have been excluded from play

Be aired or posted without I-800-GAMBLER



# Advertising Standards Proposed

## Advertisements should not:

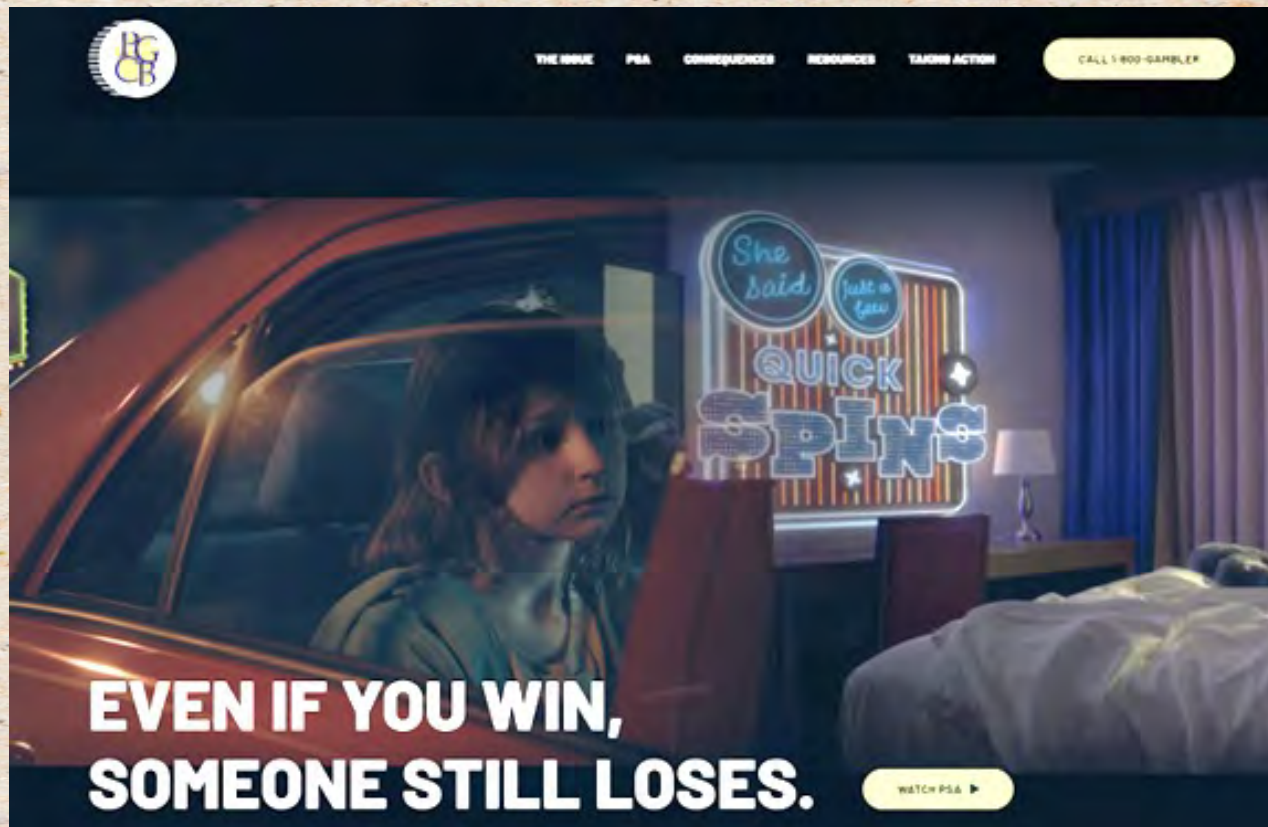
**Encourage players to chase their losses or re-invest their winnings**

**Suggest that gambling is a means of solving financial problems or is a way to pay bills**

**Guarantee winning or imply that chances of winning increase the longer one plays or the more one spends**
